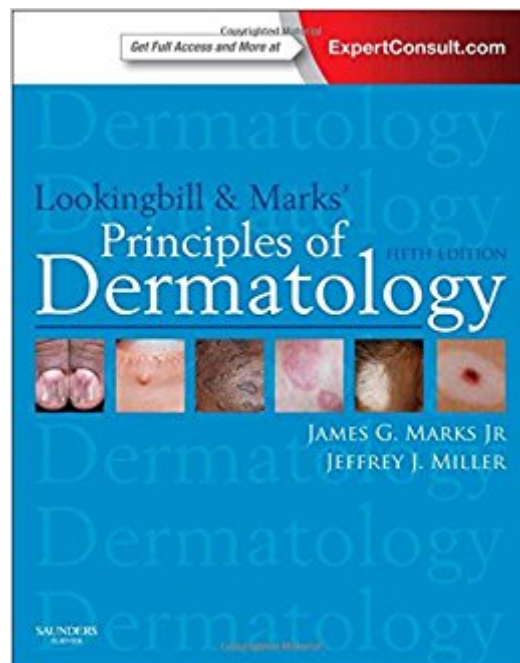

students who need to know more dermatology. The chapters are divided in a useful manner - epidermal growths, dermal and subcutaneous growths, eczematous rashes, papulosquamous rashes, etc... This organization helps you develop differential diagnoses. Additionally it gives you a basic break down of the pathogenesis as well as specific treatment options. My favorite part, and what I find unique to this resource, is that with every condition, there is a drawing that shows the level of the skin that is affected. This is so helpful for fundamental understanding. I have other more exhaustive dermatology reference books - Andrews, for example. However, the other references would have been more useful all along if I had read this book first. You have to have good fundamentals to understand and recognize zebras.
