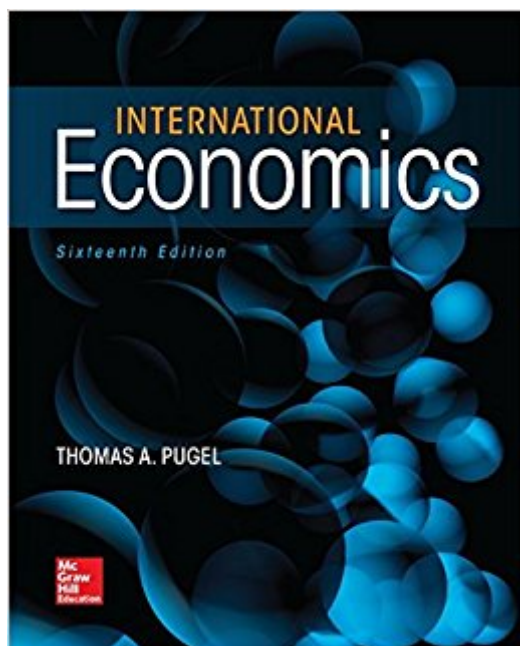

It doesn't bombard you with so much econ-mumbo-jumbo that you can't understand what you're reading but it's written with great detail in eloquence so it's easy to understand and learn. Out of all the economics textbooks I read in college, this was the only one I liked. Some topics, however, can be rather boring which is why I didn't give the book 5 stars. Certain chapters could use more sprucing up to make them a bit more interesting.
