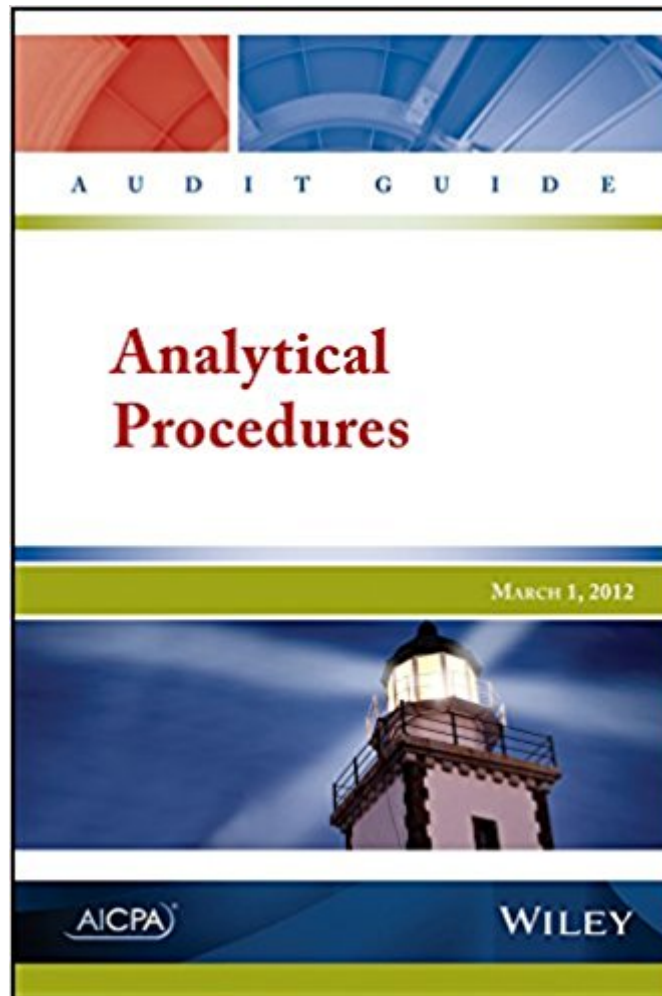

Auditors should continue to use the previous edition of this guide (2008 edition) until the clarified auditing standards become effective for the auditors' engagements.
