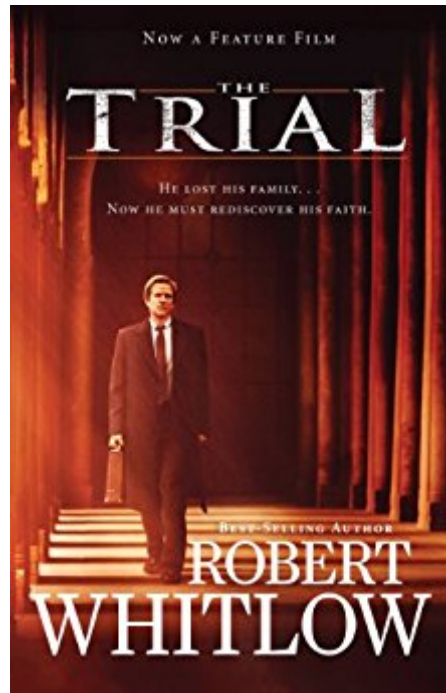

Having worked in the legal field all my life, I enjoy reading legal novels/thrillers. I usually read reviews prior to downloading a book and noticed several comments that the author was a "Christian writer" and some reviewers saying they would have preferred less references to Christianity in the book. That only intrigued me. Some of the Christian "references" (from the Bible) were at the beginning of new chapters - along with quotes from other authors, including Shakespeare. "Mac" MacLain is an attorney who has suffered an enormous tragedy in his life and now faces the trial of his career. He goes to Sunday school, although it's to discuss the winning college football team (Tennessee being his favorite) and there is a church "circle" who pray for the members. The spirituality of the characters are well woven into the overall plot of the book. It's a good legal thriller, with twists and turns, and minimal violence. I enjoyed it immensely.
