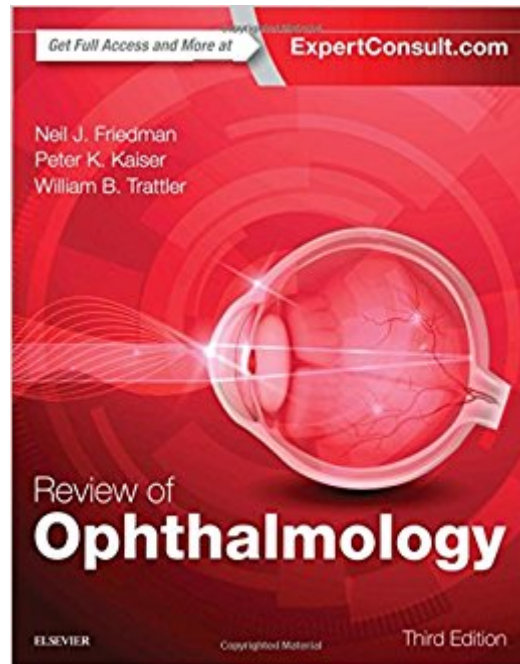

This is a succinct review of much of the material covered in the US-based OKAP MCQ exam, although it's definitely useful for other national ophthalmology exams. If you've taken the USMLE, you will probably be aware of the "First Aid" series of review books - this is essentially the same type of book, but for ophthalmology. This book combined with a decent question bank like OphthoQuestions should pretty much cover you for the OKAP. A big improvement to this book would be to add in memory tools/mnemonics similar to the First Aid series.

Great book, a must have for residents and fellows. Packed with the essential info for the OKAPs and boards. The new book has many new questions in every chapter. Totally disagree with the first reviewer (1 star? really?). You should be done taking OKAP and written board exams within 4 years so once you buy the book, you don't necessarily need to update it. But if you haven't gotten this book, then why wouldn't you buy the new edition? Obviously some topics/material don't change over time (i.e., optics, anatomy, embryology, and lots of diseases and their pathophysiology, symptoms, signs, genetics, etc.), but some do and are updated in the new edition, plus lots more questions added to end of each chapter.

No much difference from the previous edition. Same design, pictures and scientific material. If you have the previous edition, do not buy this one.
